

Microsoft Office 365 Adoption

- As of Q2 2016, 22.3% of enterprise employees use at least one Office 365 application
 - Up from 6.8% in Q3 2015
- O365 means different things to different people/departments in the same enterprise

Customer's Perspective

- Goals and Drivers for Microsoft Office 365
 - Cost savings
 - Cloud flexibility/scalability
 - Better integration/collaboration of Microsoft Office applications
- O365 Impacts
 - Compatibility with Outlook and other on-prem applications
 - Migration (resources, testing, data access)
 - eDiscovery Processes/Legal Holds/Investigations
 - Records Management Processes (retention, access)
 - IT Processes (termination, data sharing/access, investigations)

Customer's Perspective

- Potential Risks
 - New content types – skype, yammer, sway, etc.
 - Retention control – personal OneDrive content
 - Disposition of ROT
 - Security (can the correct users be granted/restricted access?)
 - Timelines (can current access/downloads of data be maintained?)

Archiving Benefits

- **Implement Holistic Governance**
 - eDiscovery, compliance, records management
 - Collect and analyze enterprise content across sources
- **Reduce Risk**
 - Eliminate ROT
 - Analyze for PII, sensitive information
 - Secure content appropriately
- **Improve Access**
 - Organize data
 - Index content
 - Provide approved legal, IT, HR access
- **Decrease Spending**
 - Enforce retention and disposition schedules
 - Reduce overall data footprint
 - Streamline processes for legal, records, IT
 - Eliminate maintenance & infrastructure of legacy applications

How Archiving Prepares You for O365

- **Reduces Migration Stress**
 - Enables data cleanup in preparation for O365 rollout
- **Allows for Consistent User Access to Existing Content**
 - Provides backed up content to retain data completeness
- **Lay Out an Ideal Information Governance Strategy and Expectations**
 - Ensures that these governance strategies are transferred and known to end-users of the new system

Information Governance Gaps in O365

- **eDiscovery**
 - Necessary to export large amounts of data
 - Data comes from variety of sources outside Microsoft Suite
- **Compliance**
 - Limited compliance features depending on deployment model
- **Data Sources**
 - Only works with Microsoft-compatible applications
 - Over 40% of sensitive information is stored in non-Microsoft Office formats

Archiving for an O365 Customer

- **Holistic Governance Across Data Silos**
 - Archive allows for single point of control for information governance
 - O365 represents a new source of a wide variety of content and collaboration formats which require governance
- **Consistent eDiscovery Processes**
 - ECA search of archived content, pro-active eDiscovery
 - Case organization and review across content types
 - Notification and analysis without duplication/movement of data
- **Analysis and Compliance Review**
 - Route collected content through lexicon rules for categorization
 - Apply retention, review routing, and retrieval based on results
 - Streamline compliance review and report on review statistics

Takeaways

- Know your license and functional entitlements
- Know the game plan for what content/users will make the move to cloud
- Consider a cleanup before the move
- Moving to O365 is a process, and the process can be a multi-year phased plan
- Consider your information governance strategy—O365 might not be the only solution you need to achieve those goals
- Involve legal team before O365 decision is made
- Document and share legal/information governance requirements during each phase of O365 project
